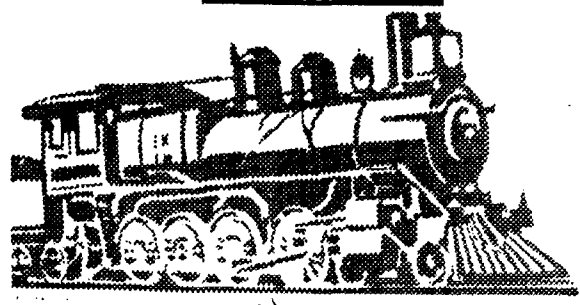

## Habitat to break ground in East Jordan

A small group met on a recent cloudy afternoon to initiate the process that will culminate with a new home for an East Jordan family.

Sponsored by Northwest Michigan (NWM) Habitat for Humanity, the modest home will be built from scratch almost completely by volunteers, including the family chosen to live there.

The local affiliate of Habitat for Humanity International serves Charlevoix and Emmet Counties in the building of single family homes for families who are usually living in substandard or inadequate rental housing and could not get approval for a conventional mortgage.

Once the family is selected, they choose either a two or three bedroom house of approximately 1,000 square feet from a catalogue of floor plans. The family is required to contribute 250 hours of labor per adult towards building the house.

The completed no-frills house is sold to the family on an interest free 20 or 30-year loan. The market value of the home generally exceeds the goal sale price of \$30,000.

"The mortgage program eventually pays for itself," explained David Knight, NWM Habitat President of the Board of Directors. The organization, still in its "adolescence" locally, has been able to build two houses since established in 1991, one in Boyne City and the other in Alanson.

East Jordan was targeted for the third project. Another board member, Walter Kaufmann, alerted NWM Habitat of a possible site, on the corner of Bridge and Echo Streets. The vacant lot, owned by East Jordan Public Schools, was listed for sale.

About the same time NWM Habitat received an unrestricted grant from the Charlevoix County Community Foundation.

"The timing was perfect," said Foundation Executive Director Robert Tambellini. The grant and the lot price being about equal, the deal was swiftly achieved.

Knight said the Habitat hopes to complete the family partner selection process and break ground by early summer. The organization will be looking for volunteers to help build. Those with trade skills are more than welcome, but Habitat stresses that no special knowledge or experience are needed to volunteer. Just a willingness to work. Cash donations also help to defray costs.

After all, the new home does not just benefit one family, but the whole community.

*NWM Habitat is governed by a board of 12 volunteer directors representing a broad cross-section of religious denominations and geographic areas of Charlevoix and Emmet Counties. The board's role is setting overall policy and direction for the organization.*

*NWM Habitat has no paid staff, although some aspects of the home building process require the subcontracting of skilled tradesmen and/or licensed construction supervisors.*

*The board hopes to build two Habitat homes per year in the area. The organization accepts donated*

lots, as well as donations of cash and labor. Most donations are tax deductible.

### Habitat for Humanity seeks family

Applications are now being accepted from families interested in becoming a Habitat for Humanity partner family for a home building project in East Jordan.

Northwest Michigan Habitat for Humanity, which serves Charlevoix and Emmet Counties, has purchased a building site in East Jordan and is now looking for a family in need of better housing with whom it will build the home.

General criteria for Habitat's family selection process are that the family be living in substandard conditions, such as too crowded, inadequate heating or plumbing, unsafe wiring or other such deficiencies. Habitat looks for families in low income brackets who would typically not qualify for a mortgage from a conventional lender. Single parent families are welcome to apply.

The family will be required to devote 250 hours per adult member to the project. The completed home will then be sold to the partner family on a 20-year, no-interest mortgage.

### Ellsworth Village Market

"It's a whole new concept," said Ellsworth Viking Foods co-owner Ron Hext, as he opened the huge oven door to check on baking loaves of bread.

The new pizza/bread oven is part of a major overhaul of the Center Street market under the guidance of Hext and his partners: wife Nancy, brother Roger and his wife Alice.

"We've virtually remodeled the whole store," said Ron. Even the name will be changed, to Ellsworth Village Market.

The hub of the store is the new pizza kitchen.

"We're going to make a good pizza and we're going to stick with it," promised Ron. They also offer a variety of submarine sandwiches, with fresh meats served on rolls baked daily by Ron and baker Mary Chessman.

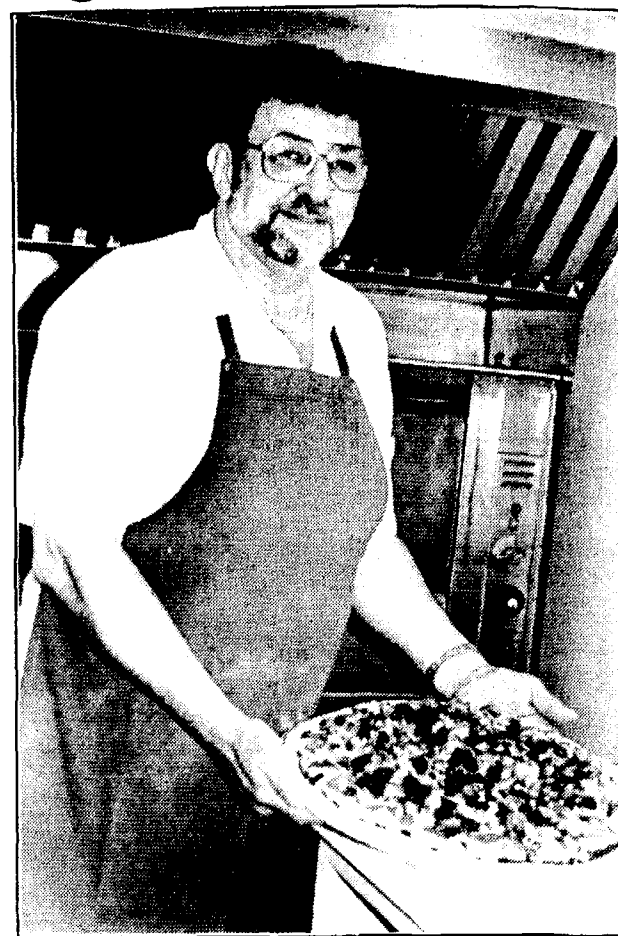
The grocery section will also reflect the change. The market will now offer only basic grocery supplies, limiting selection and variety to one brand name.

The Hext family also will not abandon their bakery and restaurant customers. They will continue to offer a varied menu of "down to earth home cooking" for breakfast, lunch and dinner, with counter and dining room seating.

Ron's homemade smoked meats will continue to be available as well.

Bakers Chessman and Jan Rasmussen will continue to offer specialty goods and all types of cakes, including special order sheet and wedding cakes.

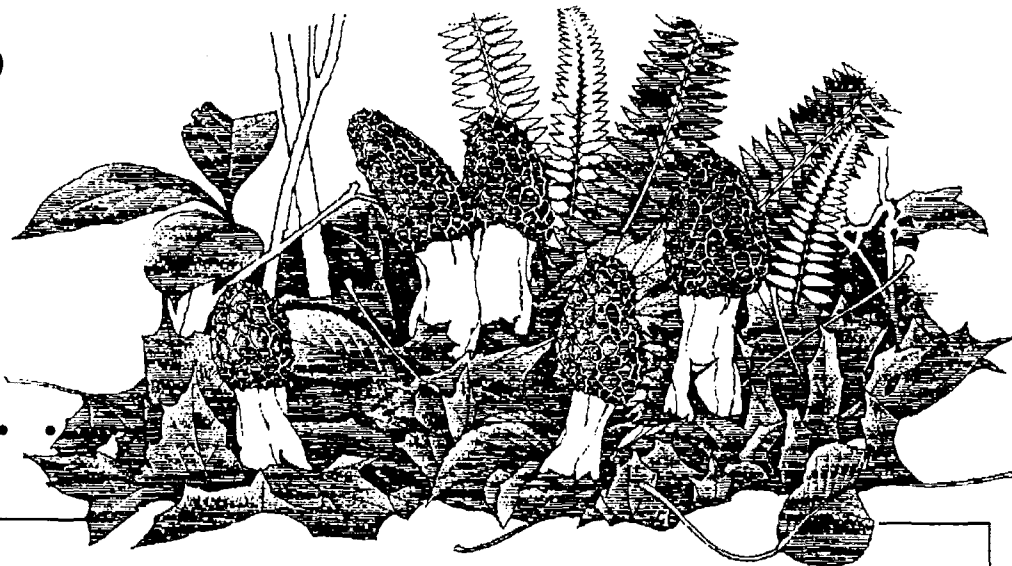

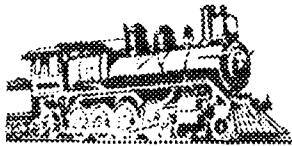

Eastport grocery six years ago.

"We decided we could do it for ourselves," explained Mary, "and we wanted to move up north." When they heard of the store for sale in Eastport, they took the plunge. They now also own Andy's Market on West Garfield in Charlevoix.

The Ramseys wanted the up-date, not just for looks, but so they could increase their stock.

When they first bought the market, Mary said, it was obvious the previous owners were running it as a summer business. But the Ramseys have increased the appeal for year-round residents and want to continue to improve their service to the community.

The Ramseys offer a full line of grocery items, as well as the bakery, a delicatessen and prepared sandwiches served on bread baked daily.

There is also gasoline,

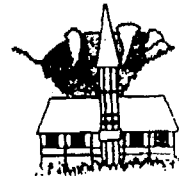

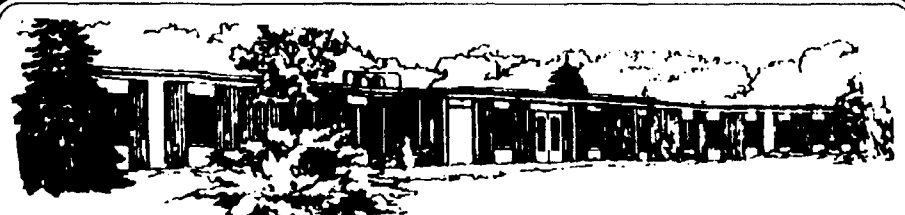

Charlevoix Area Hospital is opening its doors for area residents to come in for a "spring health check-up" on Mon., May 9.

The event is part of the hospital's participation in National Hospital Week. There will be free hearing tests, blood pressure checks, colorectal cancer detection kits, and respiratory therapy pulse oximeter tests. For \$5, a total cholesterol test will be done and, for another \$2, diabetes screening will be included.

Richard L. Krueger, hospital president, says, "The theme of hospital week is 'Building a

healthy tomorrow today.' So, we decided to go all out to help people become aware of the importance of healthy living habits and regular examinations."

There will also be displays from Healthwares, Inc., a hospital affiliate which offers durable medical equipment and home nursing services; and the Womancare program of the District Health Department No. 3. In addition, parents may bring in their child's immunization records and a health department nurse will check it to determine if it is current, or if shots are due.

Hours for the tests are varied. Munson Medical Center's Ear Lab will be on hand from 9 a.m. to 4:30 p.m. Hearing tests take about 10 minutes and can be scheduled during the day on May 9. The pulmonary function tests, cholesterol, diabetes and blood pressure tests will be available from 7 a.m. to 3 p.m. Those wishing a diabetes test should either fast or have the test no sooner than two hours after eating. All tests will only be done for those 18 years of age or older.

# A Word Fitly Spoken: Mother Love . . . . .

"Her children arise up, and call her blessed; her husband also, and he praiseth her." KJV Prov. 31:28  
 "As one whom His Mother comforteth, so will I comfort you." KJV Isaiah 66:13

## Ellsworth School Board Briefs: April 11 meeting

### Campbell successor discussed

The curriculum committee suggested the school look for someone with a background in computers, business, math and science to replace retiring coach/teacher Hugh Campbell.

No major curriculum changes were recommended by the committee.

"We'll be maintaining the status quo as far as curriculum goes," Superintendent Rick Diebold said. "Any fine tuning will involve school hours and refining the schedule for time conflicts."

The board hopes to have the fall semester schedule completed in the next few weeks.

The curriculum committee did recommend that the high school add a lower-level general math-type course directed at non-college-bound students. The new teacher replacing Campbell should have the ability to teach such a course, the committee advised.

### Ruis absence causing problems

While not yet a critical problem, the continued absence of principal Marv Ruis is a matter of concern for Ellsworth schools, the superintendent and board members acknowledged.

Ruis is currently on leave as he recovers from a heart attack suffered several weeks ago. Diebold is serving in the principal's capacity at Ellsworth schools

in addition to his superintendent's duties.

"(Diebold) can't do his job right now, as far as working on the budget," board president C. Bud Tomga said.

The superintendent said what makes the situation complicated is that the school system would like Ruis to come back to work when he's able, but the principal's doctors have not cleared him to return to work — and they may never.

Diebold said the board may want to look at hiring a short-term individual to handle student discipline and help in patrolling the school's halls and parking lot. That, the superintendent said, would free up much more time for his other duties.

"We're not to that point yet, however," Diebold said.

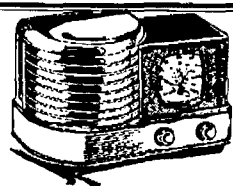

## Challenges on the journey

In this, the first of a series of articles I have been asked to write concerning life as a handicapped person, I am going to tell what happened when one day while riding with a friend in her car and I lost my "legs."

I am paralyzed as a result of spina bifida a birth defect that has left over 50 percent of my body without use. So, to get from my wheelchair to any other surface I use a transfer board.

Imagine, if you will, riding in a car and when you reach your destination, you discover that your legs have fallen off and you are immobile.

One very nice day this spring a friend and I went to Petoskey. I had an appointment at a clinic there. When we returned home my friend got my chair out of the trunk and placed the cushion I use to prevent pressure sores in the seat of the chair. Then she went to get the transfer board from the back of the seat.

Much to our horror the transfer board was nowhere to be found. My friend realized she had placed the board on top of the car roof while she was putting my wheelchair in the trunk and had forgotten to put it in the back seat. My "legs" were

gone.

We hurriedly made another trip to Petoskey knowing someone had found the board in the clinic parking lot and had turned it in to the front desk. (After all, it's obviously special - there are not too many royal blue plush-covered padded boards just lying around.)

However the answer to our inquiry was an emphatic: NO, they had not received any lost boards.

What happens when you're paralyzed and in a car and you lose your board? You sit in the car where you are for all in-

tents and purposes immobilized and wait until another makeshift board can be constructed. My friend's husband constructed just that to give me back my mobility.

If you were to lose your legs and got replacements it wouldn't be quite the same, even though they were perfectly functional legs and feet. It would take some real getting used to the new set of legs. However, as I am doing, so too would you learn to make do, and consider it another day in the life of the physically challenged.

Do you have some ideas or suggestions for subject matter for these articles? Are you handicapped and willing to share an event(s) in your life of coping with your disability? Are you the

parent, spouse, sibling, son or daughter of a handicapped person or perhaps a friend and would like to share your perspective of how that person has affected your life? We would love to hear from you!

Nancy LaCroix is a 36-year-old East Jordan native. She graduated from East Jordan High school in 1976, with further education from North Central Michigan College in Petoskey. Her hobbies include reading, writing, cross stitch and going for wheelchair walks in suitable weather. She lives independently in her own apartment at Lake View Manor, which she "enjoys tremendously."

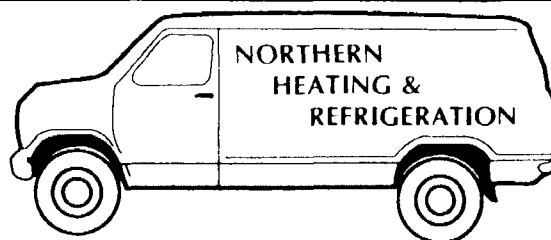

The council did vote to pay the bill, however, until they have more information. City attorney Scott Beatty was directed to research the contract with Gosling Czubak.

"We still can withhold payment at the tail-end of the project," said council member Brian Sweet. "But we better do some more homework, first."

City Superintendent Bob Johnson felt that dropping the present company would cause "considerable" problems for the city. The project is nearing completion with less than three months of work to finish.

He said that he and DPW supervisor Butch Breakey have taken over inspection duties from the company, saving the city about \$10,000.

"If it's any consolation," said Johnson.

### Public hearings set

The council will hold a public hearing on vacating two sets of alleys.

Four alleys in the Nettleton's Addition neighborhood to be abandoned by the city are bounded by Barker, McKenzie, Erie, Ontario and Echo Streets, running north-south.

On the north side of East Jordan, an alley that runs

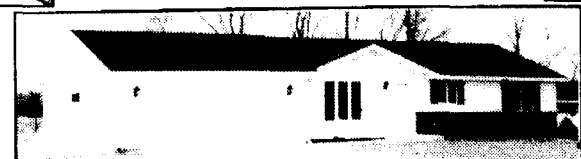

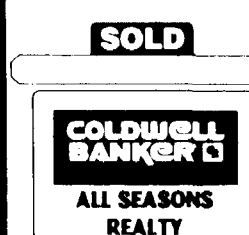
