## At A GLANCE

### Boyne interim superintendent gets the okay to stay for 02-03

The Boyne City School District is resting a little easier these days, having received confirmation that current interim superintendent Jim Cooper has received clearance from the state retirement board to maintain his current position for up to three years.

Earlier this year, the School Board, after a positive superintendent evaluation, asked Cooper to stay on at least one more year, to guide the district through its current construction project as well as to begin to resolve budget troubles. Cooper accepted, but whether or not he could continue, as it turned out, was up to the State Superintendent. Retired from the Harbor Springs school district, Cooper is subject to employment requirements from the state retirement board, which could limit his ability to maintain employment within the public school system.

Challenged by some individuals on the retirement board, Cooper's status was in limbo pending a final decision from the State. The board received confirmation of State approval last week.

According to a letter from Anthony Estell, retirement analyst for the State of Michigan Office of Retirement Services, addressed to Char-Em ISD superintendent Mark Eckhardt, "The Office of Retirement Services will honor the earnings limitation exemption granted to James Cooper for the 2002 calendar year." The letter cites the addition of "superintendent" to legal language regarding critical candidate shortages in public education as the reason for the approval. Cooper will be able to work for a period of three years.

### Area schools winding down to final days

Boyne City Public Schools' last day for students will be Wednesday, June 5.

The middle school will be dismissed at 11:08 a.m. and the elementary and high schools will be dismissed at 11:23 a.m.

The students who normally attend kindergarten in the afternoon will attend in the morning that day. The students who normally attend kindergarten in the morning will not have classes.

Boyne Falls School's last day will be a half-day on Thursday, June 6.

East Jordan Public Schools will have a half day on Friday, June 7, and another half-day on Monday, June 10, the last day of school.

## Almost there

### Area seniors preparing for graduation day

With graduation ceremonies taking place this weekend at area schools, students and school staff alike are busy making preparations for the big day.

IN BOYNE CITY, this year's graduation will mark a departure from the traditional ceremony held in the school gym, taking the first half of the event outdoors to the sports complex. According to high school principal Karen Jarema, the district has decided to hold the ceremonial portion of graduation outside, to give this year's senior class, the last to graduate from the old high school building, something special to remember. After the more ceremonial aspects of the graduation are completed outdoors, graduates and interested family and community members will be invited indoors for the customary slide show as well as songs and other special, less formal features.

Graduation will be held on Sunday, June 2, at 4 p.m.

The class of 2002 has chosen scarlet and navy as their class colors; the forget-me-not as their class flower; Led Zeppelin's "Ramble On" as their class song; and, as their class motto, "What lies behind us and what lies ahead of us are small matters compared to what lies within of us" - Ralph Waldo Emerson.

A Baccalaureate service will be held prior to graduation, on Wednesday, May 29, at the United Methodist Church, Boyne City, beginning at 7 p.m. to honor Boyne area students. For more information, call 582-9776.

EAST JORDAN High School will also hold graduation on Sunday, June 2, with ceremonies beginning at 2 p.m. at Boswell Field. The graduating class has chosen a red-tipped white rose as their class flower; scarlet and silver as class colors; and "The Times, They Are A-Changin'" by Bob Dylan as the class song. The class motto is: "They told us we could sink or swim. We chose to fly!"

## Bandshell in the works for City of East Jordan

East Jordan's Bernie Hammond, a lifetime resident and current city commissioner, has long contended that the city needs a bandshell downtown. Recently, with the formation of a committee of which he is the chair, the project has been taken on in earnest.

Citing other area communities, including Boyne City and Charlevoix, with downtown bandshells, Hammond believes that a bandshell would be an asset to East Jordan. Currently, any performers attempting to give a concert in the park don't have "anyplace to get out of the weather." The structure, Hammond said, could serve a multitude of uses, including as a permanent stage for Jordan Valley Freedom Festival concerts (currently, the festival committee must rent and assemble a portable stage each year), a platform for community band concerts, and a place for featured speakers at special events, such as the Memorial Day services, to present.

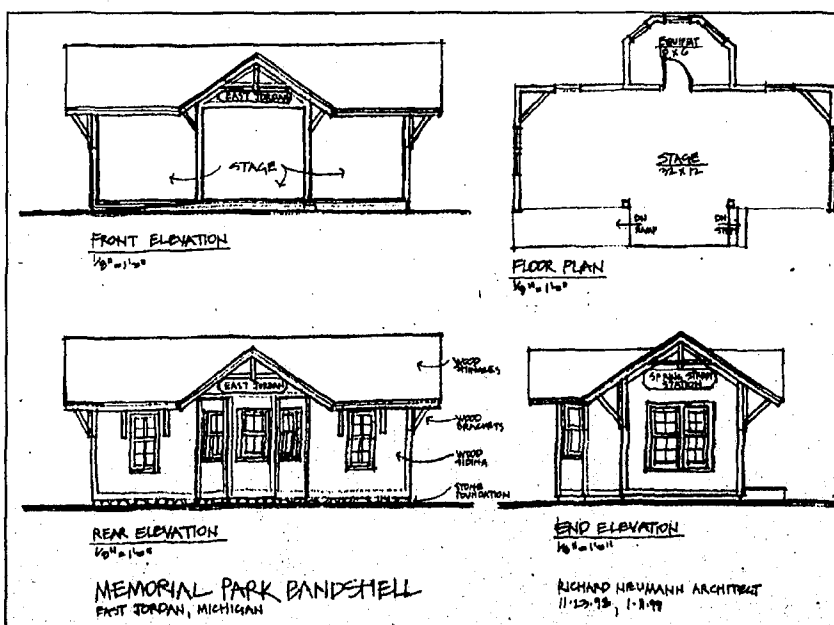
East Jordan, in fact, hasn't always been without such a structure. Where city hall currently stands, Hammond said, there was

once a bandshell, later moved to a location between what are currently Sherman's Appliance and T&R Yamaha. A large green structure, the second bandshell, was torn down sometime in the mid-40s, Hammond said, and "that's the last one we had."

After Hammond retired a few years ago, he brought the idea of a new bandshell to the city commission at the time, and received a general show of support for the idea. However, that was as far as the project got. It wasn't until another local resident, Carl Bloom, approached city administrator David White with the same idea that the ball got rolling. White hooked Bloom up with Hammond, and the two got to work putting together a committee to move the project forward.

Committee members, including White, Mary Faculak, Gordie Anderson, and Tad Malpass, have been meeting regularly, and have already received permission from the city commission, by a vote of 6-1, to use Memorial Park as a site for the construction of a bandshell.

The committee has been receptive to

## Sheriff offers tips for dealing with telemarketers

Hundreds of annoying telephone solicitations continue to plague the citizens of Charlevoix County, according to Charlevoix County Sheriff George T. Lasater, who said his office received numerous complaints from citizens and local businesses regarding telemarketers.

Due to the increase in solicitation calls, Lasater is reminding the citizens of Charlevoix County that his professional organization, the Michigan Sheriff's Association (MSA), does not conduct telephone solicitation, nor does the Michigan Chiefs of Police, or Michigan State Police. Two governmental agencies provide protection from abusive and deceptive telemarketing sales practices: the Federal Communications Commission with the Consumer Protection Act, and the Federal Trade Commission with the Telemarketing Sales Rule. These rules protect consumers and make it illegal for telemarketers to:

- call you if you have clearly stated that you want to be added to their "Do Not Call List"
- call before 8 a.m. and after 9 p.m.
- tie up your home telephone line with auto-dialed and pre-recorded messages
- neglect to tell you their company name and what they are selling at the beginning of the call; prize promotions must be disclosed, saying no purchase or payment is necessary to enter or win
- misrepresent any information
- ask for payment before telling you the total cost of goods, whether a sale is final or non-refundable, the odds of winning a prize, and any restrictions/conditions on getting the prize
- withdraw money from your checking account without expressed, verifiable consent
- request a fee before providing the service for credit repair or loan promotion, lie to get payment for any goods or services, and transmit unsolicited ads to fax machines

To stop sales calls the Michigan Public Service Commission suggests the following steps:

1. Demand that the telemarketer place your name on the "Do Not Call" list. The law requires them to honor your request.
2. Ask for the company's name and address.
3. Write down the date and time that you received the phone call and the action that you took. The Attorney General provides consumers a Telemarketer Tracking Form to record and keep track of these calls.
4. If the telemarketer persists in trying to sell you a product or service, hang up the phone.

to \$3,000. After the drawings are completed, the committee will have an idea of the total cost of the project.

The timeline, Hammond said, is two years, based on the amount of time the city commission gave the committee to complete the project. While the sooner the better, Hammond said that the two-year plan is "reasonable."

The project is expected to be funded strictly by grants and private donations, without the use of city monies. Future upkeep has already been considered, with the committee planning to build enough money into the fund-raising effort to establish an endowment fund for maintenance costs. Because it will sit on City property, the intent is that the bandshell, once constructed, will also belong to the City.

Though the project is still in its infancy, with plenty of work ahead, Hammond is encouraged by the reaction he's had from community members thus far. He's had "all kinds of positive [comments]," he said. "There's been no negative," other than some concerns about the amount of space available in the park. The plans, though, will call for placing the bandshell in the northeast corner of the property, including two current parking spaces so as not to interfere with open, grassy space any more than necessary.

Anyone interested in donating to the effort can do so through a special fund set up through the City of East Jordan. Donations are tax-deductible, and can be dropped off at City Hall. Monies will be earmarked for the bandshell effort, and will be overseen by city treasurer Susan Moreau.

## Floating tribute

■ Jordan Valley Glassworks adds something special to Memorial Day services with Nijima floats

Bartlett. Prevo. Sweet.

These longtime East Jordan names represent just a few of the local soldiers who died fighting for America's freedom. As a memorial, Jay Bavers, Glenna Haney and the staff at Jordan Valley Glassworks engraved their names and the names of fallen soldiers from the area onto colorful glass globes.

The globes, known as Nijima, are six-and-a-half inches in diameter and are replicas of Japanese floats that were once used to hold up fishing nets. The sparkling swirls of color - at least one for every fallen soldier - were launched into Lake Charlevoix throughout Memorial Day weekend.

"To us, Memorial Day is very personal because we put every name on the globes," says Jordan Valley Glassworks co-owner Jay Bavers. "We know the names of every veteran who died while serving that came from this area."

The annual tribute began as personal quests for the partners three years ago when they opened the glass blowing, stained glass business on

State Street. The list of names were collected from history buffs and area monuments. It includes soldiers' names from every war. Their hometowns include East Jordan, Charlevoix, Ellsworth, and Boyne City.

This year, the event had additional significance.

"After the 9-11 attack, I think we all have more awareness of what our soldiers have done for us and what we have," Bavers says.

Before launching, each of the 165 globes is inscribed with "In Memory Of," the soldier's name and the name of the war they died fighting.

"People will remember the soldiers' names as long as they have the globes," Bavers' partner Glenna Haney says. She grew up in Hawaii while her father was serving in the U.S. Navy.

"These people died so I don't have to," said Bavers, a former member of the U.S. Army.

The partners' personal quest has become a community celebration that now follows the East Jordan Memo-



rial Day Parade. The globes were released from the city docks, with mayor Ron Klooster beginning the tribute by lowering the first Nijima into the water. As onlookers watched, the glistening globes floated into the distance and disappeared.

"Please remember the sacrifice they made," Haney said.

Jordan Valley Glassworks prepared 165 globes for the memorial service. Each globe is crafted by Bavers, Haney, or Jay's son Bill. Inscriptions

were made by Shellie Bavers, Jay's wife, and Beth Bavers, Jay's daughter. Each globe takes between 10 and 15 minutes to make, not including the inscription.

When all the glass and coloring is melted, twisted and looped into place, Jordan Valley Glassworks will have invested about \$7,400 in the memorial.

"It's our gift to the veterans and to the community," Bavers said. "We're happy to do it."

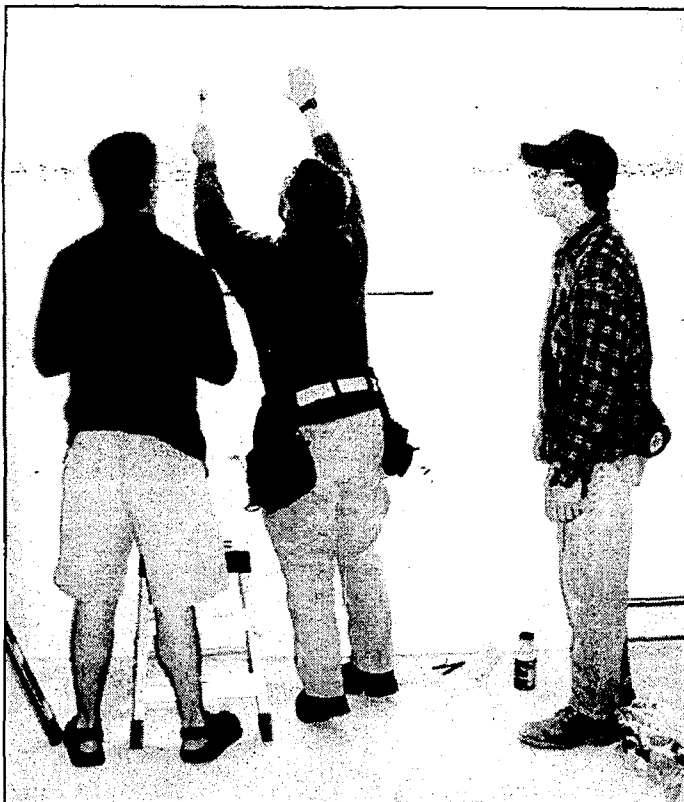
The public is invited to take a look at the students' handiwork at an open house to be held Monday, June 3, from 4-9 p.m.

## Boyne girls just keep on winning

The Boyne City Ramblers hosted the Lake Michigan Conference Championship on May 22 at Brotherston Field, and once again, the girl's track team emerged from their cocoon with an awesome display that included five new school records to win the meet. The boy's track team finished a surprising third place behind powerhouse teams from Charlevoix and Harbor Springs.

This was only the second meet all season that the track teams competed in temperatures above 45 degrees. The Rambler girls spread their wings and flew, as they set new school records in the high jump, long jump, 300M hurdles, and the 1600M and 3200M runs. Freshman Kim Foster jumped 5' 2" to break the school record of 5' 0". She then went to the long jump and jumped 15' 2.5" for a personal record and second place. First place in the long jump went to teammate Kriste Gaither at 16' 3.5" to break her own school record of 16' 1" set last year. Gaither is headed to the state meet in the long jump. Kelsi Brewer had to chase down teammate Jenna Pearsall to win the 300M Hurdles in a new school record of 48.55 seconds, as the Ramblers went 1-2 in the event. Jenna Pearsall dropped her personal best by two seconds in the race. Sophomore Emma Dunne broke two school records on the day. She broke both the 1600M and 3200M run records formerly held by teammate Jane Stieber. Dunne took 2 seconds off the previous record in the 1600M and more than 14 seconds off the 3200M record, which were set by Stieber in her freshman year. "Emma was really motivated to run well. She ran with great determination," said coach Andy Place.

"Our goal was to pick up points in as many events as possible," said Place. "We expected a close meet." Place expected tough competition from Kalkaska and Charlevoix. Boyne City won the meet with 143 points followed by Kalkaska with 84, Charlevoix 68, Elk Rapids 64, Traverse City St. Francis 58, Harbor Springs 58, and East Jordan 48. "This was a real team victory," he said. "We were not running for records. We were running for places. We were trying to beat the nearest competitor in each race. All of these little wins led us to a team win. Everyone did her part. It was an awesome display of talent."

The Ramblers won seven of the 17 events and placed second in six events. Juniors Sarah Hall and Jenna Pearsall finished their seasons undefeated against conference opponents, in 100M dash and 100M hurdles, respectively. Brewer, Foster, and Gaither won their events while smashing school records. Dunne finished third in the 1600M and second in the 3200M. Jane Stieber was second in the 800M as she edged Charlevoix's Liz Ulrich at the finish line for the second week in a row.

Stieber led the winning 3200M and 1600M relays and the second place 800M relay. Mindy McCutcheon, Hannah Decker, and Brie VanDam joined her in the 3200M relay. McCutcheon, Decker, and Brewer joined her in the 1600M relay. Hall, Brean Smith, and Brewer joined her in the 800M relay. Brewer was also part of the second place 400M relay with Crystal Laurie, Gaither, and Hall. "Jane and Kelsi led our scoring in both their open events and their relays. We will really miss them next year," said Place about the seniors.

Place also noted performances by underclassmen Brean Smith, Katie Martin and Malorie Lehto will help give strength to next year's team. For the seniors, this is their second Conference championship in three years. No championship was awarded last year: the Ramblers were ahead when the meet was cancelled halfway through the events due to thunderstorms. Place added, "The seniors have waited a long time for this. We

feel this championship is like two-in-one."

On the boys side of the meet, the Ramblers received scoring from their youth to propel the team to a third place finish. Charlevoix, Division 11 Regional champs, and Harbor Springs, Division IV Regional champs, traded the lead all through the meet with Charlevoix prevailing

with 142 points and Harbor Springs with 137 points. Boyne City finished third with 72 points, Kalkaska 57, East Jordan 57, Traverse City St. Francis 43, and Elk Rapids 19.

"It was a surprise for us," said Boyne City boys' coach Tom Nagurka. "We didn't even think about the team score. We were trying to get everyone to finish out the season with their best day of the year." Although sprinters Kyle Gibbons and Aaron Sulak were upset in the 100M dash, they came back to finish 1-2 in the 200M dash. Gibbons and Sulak finished 2-3 in the 100M. Ben Hausler finished sixth in the 100M. Boyne City placed well in the sprint relays, taking second in the 800M relay and third in the 400M relay. Gibbons and Sulak teamed up with Hausler and Randall Sutton in both of the relays. Gibbons and Sulak are headed to the State meet in the 100M, after finishing 1-2 at the Regional.

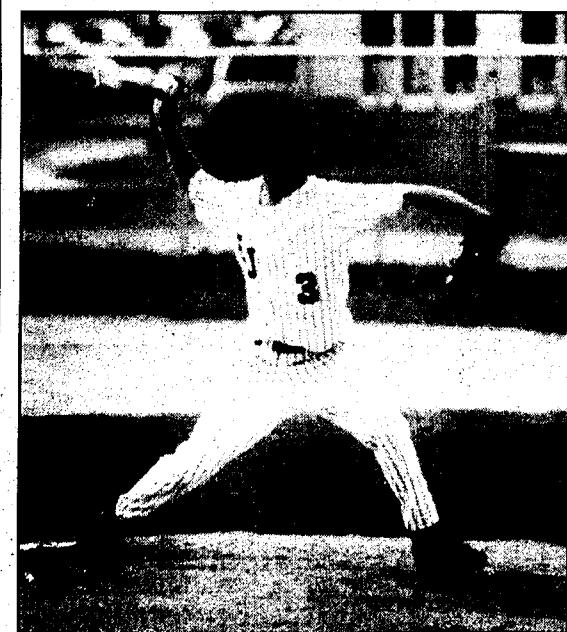

## Tim Smith returning to BCHS basketball

As the third Boyne City varsity boys basketball head coach in three years, Boyne Falls native Tim Smith knows what his biggest challenge will be — bringing a sense of stability to the program.

With a record like the one Smith brings to Boyne City, though, that goal is well within reach. One of the most successful coaches in the history of Gaylord St. Mary's basketball, Smith is leaving behind an overall record of 110-30 in six seasons, four seasons with more than 20 wins, four turns as district champs, traveling twice to the quarterfinals, and a 2002 berth in the Final Four. Smith, the second winningest coach in Gaylord St. Mary's history, has decided it's time to come home.

No stranger to the Boyne City schools basketball program, prior to his six-year stint at St. Mary's Smith served two years coaching at Boyne City Middle School, a year as freshman coach at BCHS, and a year as junior varsity coach.

The move to Gaylord was the right one at the time, but, with two kids in their teens and in Boyne area schools, as well as a baby at home, Smith found the opportunity to work a little closer to home appealing. "[The prospect of coaching in Boyne City] opened a lot more avenues to do more in [my kids'] lives," Smith said. "Going to Gaylord every day limited some of the things I needed to do." Still, the decision to walk away from such a strong program wasn't an easy one. "As I look back, it will be one of the tougher decisions I've had to make in my life," Smith said. "I'm leaving a really nice team. The program is in real good shape. I can truly say I've loved every kid I've ever coached over there. I've developed so many good relationships and friendships — they'll probably go on for a long time. It's tough to walk away from those situations."

Looking forward, Smith knows, program-building will be task number one. "I'm hoping with the success I've had in the past that I can bring some credibility [to Boyne City's program]," he said. throw of 42' 7". Brenton Rozycki threw a personal best 42' 4" to finish seventh.

The third place finish is the best in recent history. "We will miss the seniors. We have a young team and I'm excited about next year," said Nargurka. Nargurka has been coaching the boy's teams for 15 years.

Last week, the Boyne City girls track team used their depth to place fourth in the 15-team MHSAA Regional meet on Friday. Host Mason County Central won the meet with 110 points followed by Kingsley 57, Benzie Central 56, and Boyne City 52.

The Ramblers did not place first in any event, but had 12 different girls earn medals by placing in the top six in their events. In addition, six girls qualified for the State Track finals with their performances.

The 3200M relay team consisting of Mindy McCutcheon, Hannah Decker, Emma Dunne, and Jane Stieber finished second to qualify for the state finals. Despite a baton exchange problem, the relay team edged the Charlevoix team at the wire to capture the second qualifying spot. Jane Stieber gave a herculean effort to make up 20 meters and pass Liz Ulrich of Charlevoix at the finish line. This is the fourth consecutive year that the Rambler girls have qualified a 3200M Relay team. Jane Stieber and Mindy McCutcheon have been on all four of those teams.

Katie Martin finished second in the pole vault to qualify in that event. She vaulted to a personal record of 8' 6", which is also state qualifying height. Kriste Gaither finished fourth in the long jump, but jumped 15' 8.75". The

distance qualifies her for the state finals. It was Gaither's longest jump of the year. "It was the toughest long jump competition I've seen," said Place. "The top six girls all jumped over 15 feet. Kriste was less than an inch from second place."

The Ramblers had another athlete close to meeting qualifying standards. Sarah Hall finished third in the 100M in 12.92 seconds, which was just .02 seconds over the qualifying standard. Other top finishes for the girls were Kim Foster, fourth in the high jump, Jenna Pearsall, fourth in the high hurdles and sixth in the 300 hurdles, Kelsi Brewer, fourth in the 300 hurdles, and Emma Dunne, fifth in the 3200M run and sixth in the 1600M run. The 800M relay team of Jane Stieber, Sarah Hall, Brean Smith, and Kelsi Brewer finished fifth and the 1600M relay team of Brewer, Decker, Brie VanDam, and Stieber finished fourth.

"It was an excellent team effort," he said. "We came in with some high expectations. Many of them were met."

Earlier in the week the Ramblers won a four-way meet in Charlevoix. Boyne City scored 69 points followed by Harbor Springs 58, Charlevoix 53.5, and Elk Rapids 52.5. The meet had been rescheduled to Tuesday due to poor weather earlier in the season. The meet was billed as an opportunity for underclassmen, not scheduled to compete in the regional, to compete again before the end of the season. "We gave our kids a chance to run anything they wanted," said coach Place. "We picked up some surprise points." Place noted that distance runners Brie VanDam and Hannah Decker placed fourth and fifth in the 100M Dash. Hurdler Kayla Eaton

placed 4th in the long jump. The 3200M relay team, made up of seniors, edged out the underclassmen team for second place. Jane Stieber won the 400M and 200M races. Sarah Hall won the 100M. Jenna Pearsall won the 100 high hurdles. Kriste Gaither won the long jump. Kelsi Brewer won the 300 hurdles. Malorie Lehto finished fifth in the discus with one of her best throws of the season at 68' 7". Robyn McCarry finished fifth in the shot put.

The Boyne City boy's team finished seventh overall at the Regional. A very powerful Charlevoix team won the regional championship by winning many of the distance and relay events.

However, the 100M dash belonged to the Ramblers. Kyle Gibbons and Aaron Sulak finished 1-2 in a very close race. Both sprinters will be representing their team at the state finals in Comstock Park.

Gibbons finished third in the 200M and Sulak sixth. A leg cramp caused Gibbons to pull up right before the finish.

Gibbons had run qualifying times in the semi-final heat, but the long cold day took its toll on him in the finals.

"We had several good performances," said coach Tom Nargurka. "Randall Sutton had his personal best in the long jump. It was nice having Ben Hausler back." Nargurka also noted the performances of throwers Matt Mercier and Brenton Rozycki.

**EAST JORDAN'S** Courtney Hammond has had a run of good luck, with two first and two second place finishes at the conference meet, as well as a first in the 400M and a second in the 200M at the regional meet.

At the conference meet in Boyne City, Hammond had her season bests in the 200M and 400M, with a 400M time of 59.71 to break the school record.

"She has finally got her pacing for

this event, and could be a pleasant surprise at the state finals," said East Jordan girls coach Dennis Snarey. "Charlevoix's assistant coach Bruce Waha gave her some great advice before her record run."

At regionals, "Courtney accomplished just what we had hoped for by taking second in the 200M and first in the 400M," Snarey said.

The East Jordan girls finished seventh overall, while the boys took fourth overall in the conference meet.

Other top finishers for the East Jordan girls at the Lake Michigan Conference meet were: Heather Hammond, who finished seventh in the girls' 400M dash, with a time of 1:06.20 and third in the girls' long jump, with a jump of 14-10.5; and Amanda McMichael, who placed third in the girls' high jump, with a jump of 4-09. The East Jordan girls also had their relay team place second in the 400M relay.

Top finishing boys at the conference meet were: Taka Kida, finishing second in the 110M hurdles, fifth in the 300M intermediate hurdles and third in the boys' high jump; Peter Warnos, finishing ninth in the 400M dash and first in the pole vault; Jeremy Penzien, finishing second in the 300M intermediate hurdles and fourth in the 110M high hurdles; Kyle Daneff, with an eighth place finish in the 110M high hurdles, and a 10th place finish in the 300M intermediate hurdles; Garrett Romero, with a sixth place finish in the 800M run; Josh Smith, seventh in the discus throw; and Richard Derenzy, finishing 16th in the 400M dash. The East Jordan boys took home third and fourth place wins in the 800M and 400M relays, respectively.

### 'Sneaky' Glaucoma is serious, but treatable

Dear Dr. Hufford,  
What is Glaucoma, and is it treatable?

Spence B., Boyne City

Glaucoma is a very sneaky disease that causes an increase in the production of fluid into the eye or a reduction in the drainage out of the eye. This results in a rise in the pressure.

The inter ocular pressure (I.O.P.) is measured with an air puff machine (that so many patients love) or with an instrument that uses a blue light and a special contact lens like probe. The normal pressure range is 10 to 25.

When glaucoma is present the pressure is over 25.

Exactly what causes glaucoma is unknown but it is very treatable.

Treatment is usually drops two to four times per day. These drops lower the pressure and damage to the eye stops.

Without treatment, the elevated pressure causes damage to the delicate nerves of the retina and vision is lost.

Typical loss is peripheral vision and the view keeps getting smaller; tunnel vision is the result of untreated glaucoma.

The central view is lost and blindness that results is not reversible.

It is important to know how you can not feel the pressure being elevated. Therefore, it should be checked at least every other year at your examination, and more often if there is a history of glaucoma in your family.

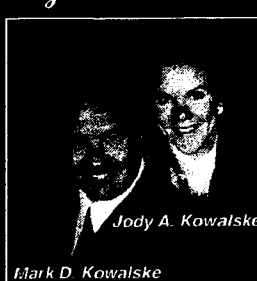
