Petoskey girl nearly drowns at **EJ Tourist Park**

The Charlevoix County Sheriff's Department and the East Jordan City Police Department are investigating a swimming accident at East Jordan Tourist Park in which a Petoskey girl nearly drowned.

According to the sheriff's department, the 11-year-old girl was swimming on a sand bar in a non-swimming area near the Tourist Park with her brothers and friends when she went underwater and didn't come back up. The East Jordan Fire Department dive team and EMS were called to the scene. The girl was located by dive team members in approximately 20 feet of water: she had been underwater for at least 25 minutes prior to being located.

East Jordan EMS transported the girl to Charlevoix Area Hospital without a pulse. As of 6:30 p.m., Charlevoix Area Hospital had a pulse on the girl; she has since been on life support and was scheduled to be airlifted to a hospital in Grand Rapids.

The Charlevoix City dive team was called to assist the East Jordan dive team in the search

No further details were available at press time. The incident is still under investigation.


Local Glen's **Market stores** part of Spartan meat recall

Spartan Stores, including Glen's Markets in Boyne City and East Jordan, have announced a voluntary recall of all ground beef products sold under the Glen's or ConAgra beef product label with a sellby date between April 13 and July 12, 2002. Testing of ConAgra ground beef products by the United States Department of Agriculture indicated that E.coli 0156:H7, an organism that may cause serious illness in the very young, the elderly, pregnant women, and persons with weakened immune systems, was present.

The action is being taken in conjunction with the recall announced this week by ConAgra Beef Company of Greeley, Colo. According to Jeanne Norcross, director of Corporate Communications for Spartan Stores, Spartan purchased beef products from ConAgra during the time period specified. "All of the products involved in the recall should be returned for a full refund or replacement," Norcross said.

According to Norcross, Spartan Stores has received no confirmed reports of illness associated with the consumption of the recalled product. Consumers with questions about the recall can contact Spartan Stores at 1-800-451-

Resignation leaves open seat on EJ city commission

After a conspicuous absence from recent commission meetings. East Jordan City Commissioner Shane Williams submitted his resignation citing a recent move to a home outside of the city limits.

At its regular meeting on Tuesday, July 16, the commission officially accepted Williams' resignation by a unanimous vote.

Elected to the four-year seat in 1999, Williams became a vocal critic of the East Jordan Fire Department, repeatedly calling for the resignations of both city administrator David White and fire chief Glen

Early in his tenure on the commission, Williams, a volunteer firefighter, opted to assume inactive status after issues were raised regarding a potential conflict of interest.

According to city attorney Scott Beatty, the vacant seat created by Williams' resignation must be filled within 30 days of the commission's official action on the matter.

The city appointments committee is expected to have a recommendation to fill the seat by the next regular commission meeting, set for Tuesday, Aug. 6.

Once approved, the appointee will hold the seat until the end of Wil-

Results in on BC Market Study

Lakefront, river focal points of possible development

After several months in the making, the results of the DDAcommissioned Boyne City Market Study were unveiled at a special meeting held at city hall.

Presented by Howard Kohn, president of the Baltimore-based Chesapeake Group, the results were met by a cautious but interested reaction from audience members.

Though conclusions were many, the main crux of Kohn's presentation was that in terms of waterfront and downtown development, the city must take quick and decisive action.

'We do believe there should be good development on the lakefront, and that development is two-fold; on land and in the water," Kohn said. Lakefront development would include, according to recommendations, the expansion of commercial activity along the lakefront and the expansion of marina activity, and the relocation of municipal services off of waterfront property.

might be controversial to those protective of the waterfront property. Kohn also emphasized that such development should be undertaken with two primary principals in mind: continuous public access to the lakefront. and the maintenance of view vistas to the water, unimpaired by building structures.

According to DDA member Mark Kowalske, the recommendations have the potential to give the City a new take on waterfront development. "Those of us who have lived here, were born and raised here, are very protective of the water," Kowalske said. Kohn, he continued, "heavily stressed making sure to maintain that access to the public waterfront.

"I have sort of a narrow-minded approach to development, [but] his concept of pulling the stuff back from the water, either residential or retail, and allowing the public to maintain water access . . . That was new infor-

Understanding that such a position mation to me," he said. "I though it was either/or.'

The market study was originally commissioned several months ago by the DDA, in order to facilitate planning for the future of the City, in a time where growth in and around the community is creating new issues for business and development.

The Chesapeake Group was chosen, Kowalske said, in part because it's a firm that has done a significant amount of work not only in northern Michigan but all over the country. "I feel like we've got somebody who knows what they're doing," he said.

Utilizing a variety of informationgathering techniques, including business surveys, face to face interviews, and telephone surveys, the group created a comparative analysis and worked up demand forecasts for the area concentrating on retail and related service activities in the Central

Motorcycle club members face charges in beating of Boyne man

Two area men are facing felony assault charges, with charges pending for a third man, in connection with an assault that took place recently at Whiting Park Campground in Eveline Township.

Eric Peter Vaughn, 29, of Boyne City, and Marcus Damon Cornelisse, of Alba, have both been charged with one count of assault with a dangerous weapon. Richard Lee Selissen is expected to be charged this week.

According to an affidavit given by Charlevoix County Under Sheriff Donald Schneider, on July 16, officers were dispatched to the campground to assist David Wayne Loranger, 40, of Boyne City, who was reportedly assaulted and bleeding badly.

Witnesses reported that three males had assaulted Loranger before leaving the scene in a dark blue, full-size van heading west on Ferry Road.

At the scene Loranger told officers that after the men pulled up in the van, one got out and asked if he was David Loranger.

After replying in the affirmative, Loranger was then punched in the face by the man.

According to the affidavit, Loranger advised deputies that he never saw the other two suspects, "because it was kind of a blur," but he was being "punched and kicked in the face a lot

Witnesses told officers that the three males kicked Loranger in the face and smashed his head against a

Loranger also told police that until recently he had been a member of the Outlaws motorcycle club, and that the incident could have been repercussion for leaving the club.

The suspects were apprehended by Sergeant Patrick Avery, who pulled over a van matching the description of the suspects' on Peninsula Road near Dutchman's Bay Road.

The occupants, Vaughn, Cornelisse, and Selissen, were all known by Avery to be associated with the Outlaws Motorcycle Club, according to the affidavit.

After inspecting the suspects' footwear, and finding that the shoes had blood on them and that the waffle pattern on one sole appeared to match the pattern imprinted on Loranger's head, Avery arrested the suspects.

Boyne City Ambulance personnel arrived on the scene and transported Loranger to Charlevoix Area Hospital, where he was treated for head injuries, and released.

At press time, both Vaughn and Cornelisse were being held at the Charlevoix County jail on \$50,000

A preliminary hearing is scheduled for both men on Tuesday, Aug. 6, in Charlevoix County District Court.

Gaylord man faces charges in three state park assaults

The Charlevoix County Sheriff's Office arrested a 20-year-old Gaylord man over the weekend on three counts of sexual assault.

On Saturday, July 20, police arrested Scott Thomas Payton, 20, in connection with an incident alleged to have taken place on Sunday, July 14, at Young State Park in Evangeline Township.

The initial report received by police was that a 15-year-old girl had been sexually assaulted.

According to the sheriff's department; investigation has determined that three 15-year-old Charlevoix County girls had been assaulted in three different incidents while swimming in Lake Charlevoix.

The Charlevoix County Prosecutor's Office has issued felony charges of two counts of Criminal Sexual Conduct in the third degree, and one count of Criminal Sexual in the fourth degree.



# BOYNE CITY PUBLIC SCHOOLS CONSTRUCTION UPDATE


(The following update has been provided by The Christman Company and the Boyne City Board of Edu-

# Area programs benefit from state tobacco settlement funds

More than \$23,000 was recently granted to Charlevoix and Emmet county programs for tobacco prevention and cessation, and programs that emphasize healthy lifestyle choices.

The grants were made by the Charlevoix County Community Foundation and the Petoskey-Harbor Springs Area Community Foundation as part of an agreement between the State of Michigan and the Council of Michigan Foundations. The State of Michigan is one of 46 states receiving funds from the 1998 national tobacco master settlement agreement between the tobacco industry and the states.

Under anagreement with the State of Michigan and the Council of Michigan Foundations, a portion of the interest earned on the State's tobacco settlement revenue is distributed annually to the 66 community foundations in the State to fund local, health-related programs for youth and seniors.

The Charlevoix County Community Foundation and the Petoskey-Harbor Springs Area Community Foundation together received over \$40,000 for the 2002 distribution.

Half of that amount is placed in a permanent endowment by each community foundation for future grantmaking and the other half is for immediate grantmaking.

While each community foundation has its own permanent endowment to benefit their respective counties, the two community foundations have formed a joint Healthy Youth and Seniors Advisory Committee made up of representatives from health and human service agencies that cover the Char-Em area. In addition, each community foundation has a

member of their Youth Advisory Committee serve on the Healthy Youth and Seniors Advisory Committee. In the latest round of grantmaking, the two Commu-

nity Foundations each awarded \$10,769 to the Northwest Michigan Community Health Agency for their Tobacco Prevention and Cessation Among Youth -2002 project.

This is a comprehensive education and prevention project to target elementary, middle and high school students in Charlevoix and Emmet counties. The project will also include a media campaign and

educational programs for seniors. The Charlevoix County Community Foundation also

awarded \$2,000 to Planned Parenthood Northern Michigan for the How To Say No program, which teaches healthy lifestyle choices for seventh and eight grade students.

With the assistance of Sunburst Marine, organizers have selected several classic boats from the Sunburst collection, and from the collections of their clients, to feature in this year's Home Tour.



Even though Chris Craft may be the most quickly recognized name in wooden boats, classic vessels from other American and Canadian builders will also be a part of this


Other homes to be featured on the tour include the Beckenhauer House, in the Harborage, and the Shorkey House, an historical home in downtown Boyne City.
